Key Focus Areas

We continuously seek to strike a balance between people, the environment and society. Our goal is therefore to keep these three factors in balance and to always act in accordance with these core values. Care for the safety, health, working conditions and well-being of employees and third parties is a high priority within the organization and is achieved by complying with health and safety legislation and regulations and preventing personal injury, material damage and environmental damage. Creating the Right Conditions...

A certified quality, environmental and CSR management system does not happen by itself. As management, we provide resources to achieve the objectives:

- 1. Appointing a QHSE coordinator whose specific task is to maintain, coordinate and improve the quality, environmental, safety and CSR management system and ensure that it continues to comply with the requirements of the ISO 9001:2015 and ISO 14001:2015 standards.
- 2. Making capacity and financial resources available to work on improving quality, the environment, safety and social responsibility.
- 3. The appointment of an environmental coordinator. This person will provide solicited and unsolicited advice on policy developments with regard to the environment and CSR.
- 4. Ensuring that every employee is committed to and accountable for the implementation and execution of the quality, environmental, safety and CSR management system.
- 5. Improving the procurement process by choosing goods and services that are sustainable, preferably with an environmental, sustainability and/or social quality mark.
- 6. Actively sharing knowledge about sustainability and corporate social responsibility with employees, customers and partners.
- 7. Voluntarily contributing to social causes and programmes aimed at strengthening society and increasing knowledge and awareness.

We consider the quality, environmental, safety and CSR management system to be a priority and we act accordingly. We are well aware that we must set the right example; otherwise, we cannot expect the same from all our employees.
